Retirement Board Election Results

On Saturday, May 8, 2021, the results of the State Teachers Retirement Board election were certified by a board of tellers appointed by the State Teachers Retirement Board and Election Services Company — the independent firm administering the election.

The results of the election for the one contributing member seat on the Retirement Board are as follows:

- Carol Correthers, 7,470 votes
- Benjamin Pfeiffer, 5,357 votes
- Matt Sheridan, 2,877 votes
- Write-Ins, 62 votes

The results of the election for the two retired member seats on the Retirement Board are as follows:

- Rudy H. Fichtenbaum, 21,339 votes
- Elizabeth Jones, 15,926 votes
- Robert Stein, 19,592 votes
- Rita J. Walters, 17,114 votes
- Write-Ins, 114 votes

The term of office for Carol Correthers, Rudy H. Fichtenbaum and Robert Stein will begin on Sept.1, 2021, and will end on Aug.31, 2025.

OEA Educator Virtual Lobby Days June 8-9

At the lobby days, members will be briefed by OEA staff on current legislative issues and will have an opportunity to meet with state lawmakers and staff. This year is especially important as the legislature considers the **Fair School Funding Plan** – a plan that once fully implemented would provide about a 25% annual increase in state aid to our students, finally fixing the way Ohio funds its public schools.

The interaction of OEA members with elected officials is critical to getting the Fair School Funding Plan passed through the legislature, as well as improving other policies that impact students, educators and public education.

Stack the (Credit Card) Deck in Your Favor

Most cards provide an interest free "grace period" of at least 20-25 days where if your balance is paid in full each month, there are no finance charges. If you have more than one card, arrange to have the closing date for each card at different times of the month.

To implement your "deck stacking" strategy, carry or use the particular card for large purchases AFTER the closing date. You will then receive the billing for the large purchase AFTER the billing period closes and the payment won't be due until about 25 days after the NEXT billing period.
