Our Keynote Speaker – Daneé Pinckney

Please join us on Wednesday evening, July 16, to hear our keynote speaker: Daneé Pinckney, Ohio Teacher of the Year, an English teacher at Twinsburg High School, and an OEA/NEA member.

From an early age, Daneé knew she wanted to be an educator, a calling inspired by her parents and her elementary school teachers.

"You have to step out of the professional development that everybody does, regardless of who you are, what department you are in, or what subject you teach, and find the things that speak to you—the lessons, the groups, the cohorts, the residencies, the conferences that make you feel reinvigorated and passionate. I'm not saying this will fix all the problems we're seeing in public education or keep all teachers in the classroom, but it will help, especially if your heart is in it and you want to make it work."



Using literature as the anchor, Ms. Pinckney works to encourage students' engagement in community service and activism projects instilling in them a sense of social responsibility and civic engagement.

1A	Leadership Practices Inventory	In order to lead with purpose and vision, understanding your leadership assets and the liabilities of your leadership style is essential. This session provides each participant with a unique opportunity to assess their leadership strengths and to identify those areas of improvement by utilizing the Leadership Practices Inventory (LPI) which introduces "The Five Practices of Exemplary Leaders."		
1B	No Shortcuts: Organizing for Power's Core Fundamentals	Using Jane McAlevey's book, No Shortcuts – Organizing for Power in the New Gilded Age, we will engage in a collaborative discussion on how to build collective power through the use of five core fundamentals for organizing. McAlevey's fundamentals are based on the radical notion that to win the changes this world needs, we need to get a whole lot better at talking to – and organizing with – people who don't already agree with us. Each fundamental element serves as a building block for successful campaigns, and all are crucial pieces for building disciplined majorities capable of fighting and winning. Learn to Win. Teach to Lead. Organize for Power.		
1 C	Educator Rights and Responsibilities to Violence	Violence in classrooms is an area of concern for members. Did you know there are tools available for you to utilize to help maintain a safe environment? Participants will discuss available options and steps that can be taken to advocate for all students.		
1D	Yes And: Using Improvisation and Creativity to Succeed	Participants in this session will explore the Improvisational Theatre principle of "Yes And." Participants will engage in experiential improvisational theatre activities to explore how oftentimes we can say "yes" to accomplish so much more than "no!" Participants will understand how finding common ground can often be discovered when we agree (even when we don't). The outcome is often surprising and frequently funny!		
1E	New Treasurers' School (treasurers and presidents with five years of experience or less)	The responsibilities of the local association treasurer can seem ominous, especially for the first-time treasurer. OEA Secretary-Treasurer Rob McFee will give you the knowledge you need to do the job for your local and its members. This session will be tailored to the needs of treasurers who have five years or less experience on the job. Participants will focus on fiduciary duties, membership, and accounting issues, along with cybersecurity.

2A	Maintain, Adapt or Create: Which is Right for Your Local Teacher Evaluation System?	Law (HB 168) now provides the ability to maintain the OTES 2.0 framework as the method to complete yearly, mandatory teacher evaluation or 'adopt' or 'create' a different framework. What is still required? Just how much can you change? Should you consider change? What poor practices should you seek to avoid?		
2-3B	Member Advocacy— Everything You Ever Wanted to Know about the Grievance Process	Participants will learn the difference between a complaint, a grievance, and a ULP, the importance of filing grievances, and the role they play in defending their collective bargaining agreement will be thoroughly discussed. From the informal meeting to advocacy during the grievance hearing, all stages of the grievance process will be discussed and practiced. Participants will also learn how to decide whether or not a grievance should be taken to arbitration. (Must attend both parts; this session concludes at 12:15 p.m.)		
2C	Experienced Treasurers Session	This session is designed for the experienced treasurer (who has been in the job for more than five years) and will be a "what's new" in the area of treasurer responsibility. Participants will learn about changes in practices along with a cybersecurity presentation.		
2D	Parliamentary Practices	Some leaders lead from the front of the room, and some from the assembly. Whatever your role at meetings, you'll play it better if you can confidently apply "Robert's Rules." In this session, a credentialed Professional Registered Parliamentarian will focus on the basics of parliamentary procedure and allow plenty of time for Q&A.

2E	Managing and Negotiating Health Insurance	Navigating the complexities of health insurance can be challenging, but effective plan management is essential to ensure quality coverage, cost control, and member satisfaction. This session offers a comprehensive overview of how to evaluate, manage, and negotiate health insurance plans. Participants will gain practical strategies for analyzing plan performance, understanding key insurance terms and trends, and communicating benefits clearly to stakeholders. Whether you're participating on an insurance labor-management committee, serving on a bargaining team, or simply seeking to better understand health insurance, this session will equip you with the tools to make informed, strategic decisions.			
2-4F	Presidents' Cadre (from OEA)	Participants will learn about the roles and responsibilities of a local president, the essential knowledge and skills needed to be successful, as well as build connections with other local presidents from across the state. (Must attend all three parts; this session concludes at 2:30 p.m.)			
2G	Relational One- on-Ones: A Different Kind of Conversation	There are many types of one-on-ones for different uses. This session will focus on one-on-one for relational organizing. They are the core element of member engagement and serve as the foundation of building a powerful and effective local association. They are a fundament element of an effective, transparent bargaining campaign. Session attendees will witness reflect upon, and practice relational one-on-one conversations.			
2-3H	Calling All Building Represen- tatives!	This training session will help new building representatives learn the ropes and will be a refresher for experienced representatives. Learn how to represent your members in meetings with administrators, handle gripes and grievances, be a first friend-best friend for new members in your building, the art of ten-minute meetings, and much more! (Must attend both parts; this session concludes at 12:15 p.m.)			
21	Educators as Legislative Advocates – Groundwork	In the Ohio legislature, education policies are constantly under debate—making it essential for educators to lend their expertise and voice to the conversation. By building skills and capacity to conduct legislative advocacy, OEA members can become trusted partners in crafting and safeguarding the future of public education and directly influence the policies that shape classroom resources, student support, and professional protections. In this focused 90-minute session, members will receive a brief update on Ohio's top education bills from the first half of the 136th Ohio General Assembly, an overview of the legislative process, the makeup of the Ohio legislature, and the political climate in Ohio.
