## Summary: NEOEA Representative Assembly November 8, 2025 Eastlake North High School

The North Eastern Ohio Education Association held the fall meeting of its Representative Assembly on Saturday, November 8, at Eastlake North High School.

The Representative Assembly serves as NEOEA's top governing body, following a structure similar to that of the National Education Association (NEA) and the Ohio Education Association (OEA), with which NEOEA is affiliated. Representation is proportional, with each local association allotted at least two delegates and larger locals receiving additional representation.

Presiding at her third Representative Assembly, NEOEA President Sue Messinger welcomed 224 delegates and 30 guests. She acknowledged veterans in attendance and expressed gratitude to NEOEA Past Presidents, new delegates, committee members, and the NEOEA Board of Directors. President Messinger spoke about the importance of community involvement and resilience amid the challenges facing public education today, sharing how her parents instilled in her a lifelong commitment to civic engagement. She encouraged members to remain active in their locals, NEOEA committees, and communities, emphasizing that such engagement gives her hope for the future.

Although OEA officers were unable to attend in person, OEA President Jeff Wensing appeared via video to deliver a legislative update addressing topics such as the STRS lawsuit, property tax relief, congressional redistricting, and Election 2026. He also announced a statewide listening tour in which OEA officers will visit all ten districts to hear directly from local leaders and members.

During the Legislative Committee's report, delegates participated in a fundraiser for the OEA Fund, contributing a total of \$5,511.

At the recommendation of the Resolutions Committee, delegates adopted the 2025-26 NEOEA Resolutions, a document containing 188 statements of Association principles. Delegates approved four resolutions:

- B-26, Violence-Free Schools
- NEW B-35, Artificial Intelligence
- C-35, Vaccinations
- E-2, Teacher Involvement in Curriculum Development

Proposed changes to I-4, Justice and Law Enforcement in Schools and Communities, were referred back to the committee for further review.

Stephani Itibrout (Medina City TA) was elected by acclamation for OEA/NEOEA Unit 4 Representative. With no nominations received for NEOEA Unit 6 Representative or NEOEA ESP Representative-at-Large, elections for those seats will be held in the spring.

Delegates made an early endorsement of Amy Butcher for NEA Director #2 to be elected at the May 2026 OEA RA. Delegates also endorsed Clarence Daniels for OEA Member at-Large #2 to fill a vacancy that will be voted on at the December 2025 OEA RA.

Andrew Smith, President-elect and Chairperson of the NEOEA Finance Committee, presented the annual audit report, confirming that NEOEA received a clean audit.

The Social and Human Concerns Committee sponsored a clothing drive benefiting the Willoughby-Eastlake clothing closet, collecting socks, underwear, leggings, and jogging pants for local students in need.
